<p>➤ Highway: Signs fixed on Watery Lane</p> <p>➤ Hedges management - Letter to residents</p> <p>➤ Western Power Works:- Cllr. V. Blackshaw - I reported some time back with regards to the works Weston Power (WP) has carried out. I met with someone from Derbyshire County Council last week who has assured me they are working very closely with WP to ensure that temp surfaces are brought back to a fit and proper surface once works are completed. I will continue to connect with DCC on a monthly basis to get updates. There is an open case on this activity and will not be closed until DCC are happy with the resurfacing works. I understand the last part of WP activity is taking place over the next month or so, which is connecting Leathersley lane with Watery Lane. We should not expect to see this resurfacing activity take place until late summer. Concerned was raised about road compacting on Leathersley Lane.</p> <p>➤ Wall and Eld Charity – Letter from G. Thornhill In their wills of 1807 and 1885 respectively Thomas Wall and Elizabeth Eld bequeath funds to be invested to establish the charity of Thomas Wall and the charity of Elizabeth Eld for the poor.</p> <p>Both Charities were to distribute money or specific items to needy people in Foston and Scropton detailed specifications of recipients and items distributed being laid down in the terms of both charities. Over the years the terms of distributions have several times been changed to make them more relevant to changing times and in 1960 the two charities were amalgamated to form the Wall and Eld charity. Since then, the terms and reasons for distribution of grants have several times been updated to be more relevant however applications are rarely received, or grants paid.</p> <p>The administration of the charity is vested in the parish church and all documents are kept by the church. Since the resignation of the last resident vicar in 1992 I have been the chairman/secretary and so regarded by the charity commission's commissioners and Lloyds Bank where the funds are kept.</p>				

The funds are a modest few hundred pounds the only income being annual bank interests when there is any. If there were to be any donations to the charity, they would be received by me to bank. The parish council has never donated to the charity and has never been expected to.

An important purpose is to preserve the funds of the charity for this parish and not allowed to be transferred elsewhere
