#### **OPM110723/06 - Planning Applications**

• DMPA/2023/0650: Proposed change of use of land for the formation of external open storage and trailer parking area, together with associated drainage attenuation features, landscape bund & planting buffer for the expansion of Foston Park for ATL, including diversion to Public Footpath No 8. Parish of Foston and Scropton at Hanger House, Woodyard Lane, Foston, Derby, DE65 5DJ

Now receiving too many Change of Use of land applications: Councillors approval to respond to Planning with comments raised by Cllr. V. Blackshaw

"Foston and Scropton Parish Council object to the planning application DMPA/2023/0650. The proposal appears to be turning greenfield/ farming land into a car park extending even further the reach of the Dove Valley industrial park. As discussed in the June 23 meeting, as a parish council we are concerned about the reach of this industrial site into Foston and Scropton and beyond. This industrial takeover is negatively changing the character of the area and should cease".

• **DMPA/2022/1594:** HMP Foston Hall Houseblocks Response and Daylight Sunlight Response (email dated 14/06/2023) **DMPA/2022/1594:** The construction of 2 x 2 storey houseblocks (with additional rooftop plant), additional car parking, substation and generator. HMP Foston Hall, Uttoxeter Road, Foston, Derby, DE65 5DN - The above application has been amended.

#### Comment 1:

Requesting District Councillors support.

Cllrs. S. Meghani and G. Andrew are unable to vote but can make statements to the planning Committee as Ward members and are allowed to talk without any time restriction. Members of the public only get 3 minutes.

# Comment 2:

Responding to the initial planning application, F&S Parish Council submitted report with various key points and errors in the application. The applicant then submitted a further report addressing the errors but nothing concerning main objections.

# Comment 3:

What's the process concerning the amendments. Parish Council submitted a report follow planning application. Planning/Cushman Wakefield have come back with amendments. What's the process to counter the amendments or at least understand what the amendments are? So that we can get ourselves into a known position rather than an unknown position.

Onus is on the Parish Council to check out the planning website to see what documents have been uploaded, go through them and work out what's changed and then put in an objection or a set of comments as a parish council before the deadline. We can, if particularly anxious about something that might go through as an officer decision, we can elect one of the District Councillors to respond to the planning committee. The Planning Committee will have a discussion, immediately put it on hold until the next time it comes to a planning committee.
